Rooms have two beds/room, and charges include a bed and linens, shared kitchen, air conditioning, all utilities including WiFi, access to laundry facilities, 24 hour security, and daily bus transportation to and from our Naos and Gamboa facilities.

²Housing in Gamboa is a 10 minute walk to our Gamboa Lab and 20 min. walk to the Gamboa Dock that has service to BCI. Rooms have two beds/room and charges include a bed and linens, shared kitchen, all utilities including WiFi, access to laundry facilities, 24 hour security, and daily bus transportation to and from Tupper. Building 145 also has central air conditioning throughout the building and common areas for socializing.

¹Housing at Bocas del Toro is on the station grounds and includes 3 options: The Student Dorm has 6 beds per room (4 total rooms each with a dedicated bathroom), which are charged per bed. The Researcher Dorm has two beds per room (some rooms with one double and one single and others with 2 singles). The Researcher dorm is charged on a per room basis, and we encourage our visitors to arrange to share to help reduce their costs. Charges for the dorms cover towels and bed linens, shared kitchen and lounge dedicated to each dorm, access to free laundry facilities, and 24 hour security. The Cofrin and Hoch houses are fully furnished 2-bedroom houses with air conditioning for which we charge a nightly fee per bedroom.

Permits are required for 1) all fieldwork (including observations), 2) import and export of marine, freshwater, terrestrial biological resources, water and soil samples and work in protected areas, 3) all field courses in Panama, and 4) any genetics research involving the study of genetic structure of biological resources.

- Ministry of the Environment (MiAmbiente). Export Permit for Biological and Genetic Resources for scientific, academic, and educational non-commercial work. This permit can only be obtained after the appropriate MiAmbiente Research Permit to Access Biological and Genetic Resources has been granted. Applies also to CITES species. The government permit cost is \$30.00 for each participant in the permit.
- Ministry of the Environment (MiAmbiente) Import Permit for Biological and Genetic Resources for scientific, academic, and educational non-commercial work. This permit will be issued once the appropriate MiAmbiente Research Permit to Access Biological and Genetic Resources has been granted. Applies also to CITES species. The government permit cost is \$30.00 for each participant in the permit.

- A Phytosanitary and Zoosanitary Import License is required for the import of plants, animals, products, by-products, reagents, and food products of plant or animal origin, and for the import of live organisms to Panama. A license includes the import of a single item or organism. The government license cost is \$10.00. When the license includes products for animal consumption, such as medicines and vitamins, the cost is \$30.00.

- Visiting scientists, students, predoctoral, and postdoctoral fellows may store samples collected for their research (from projects carried out in STRI facilities).
- If export permits need to be obtained, samples can be stored free of charge for up
 to three months after finishing the visit, or for the period approved by the
 responsible staff of the facility.
- As STRI has limited cold storage equipment, samples must be removed from the freezer/refrigerator once the approved storage period has concluded,
 - Samples removal means processing, disposal if not required, exportation and/or donation to Cryo-collections.
- If samples remain in STRI cold storage equipment for more than the approved storage period with no justification or coordination with the staff of the facility, a charge of \$50/ft³ per month will apply to the user account until samples are removed.
- STRI reserves the right to discard unlabeled material and/or improperly packed material when annual inventory and cleaning activities are performed.
- Packing of samples for storage, export or any other procedure must be done by the PI (Principal Investigator) or a representative of the project. When removing the samples, please contact the responsible staff for assistance.
- Visitors, fellows, interns, and postdocs may donate samples to the STRI Cryo-collections. This option will ensure long-term maintenance of samples (no cost for donators), and access to samples whenever needed, as well as allowing their use to other researchers. Once the donation is approved by the STRI Cryo-Collection manager, the donator must complete the form 100.002 "Transfer of items agreement to the STRI Cryo-Collection" and provide the metadata using the spreadsheet, form 100.003 "Specimen data".
- Special cases in which a storage period extension with no charges may apply (must be coordinated and approved by responsible staff of the facility):
 - Samples belonging to visitors, postdocs, fellows who leave STRI but plan to return soon to process samples.
 - Delay in issuance of an export permit (if the delay is not caused by user).
 - Other situations not included here, but coordinated, approved, and communicated to the responsible staff of the facility.

Additional Information and Conditional Fees

- Science Support Staff: Most STRI facilities have science support staff who can
 assist researchers with minor jobs for research projects (e.g., building traps,
 installing shadecloth on greenhouses, support structures, etc.) Modest workshops
 are available for these jobs at some facilities. STRI will charge a daily fee for these
 services and the researcher will cover the cost of all materials. Contact the facility's
 Scientific Coordinator Contact the coordinator to organize the work required.
- Greenhouses: Greenhouses are available in Gamboa and BCI.
- Office space: STRI provides shared office space and access to computer rooms to visitors that is included in the facility fee. There is no charge for Wi-Fi connections. Please contact the facility's scientific coordinator to coordinate office space.
- Laboratory space: Each of our facilities is equipped with common laboratory space with basic equipment. Contact the facility's scientific coordinator for more information.
- Exclusive use of space: When available, a researcher may request that exclusive space be assigned to their project (e.g. office, lab, storage). This may include times when a project requires space for a technician to work even when the project PI is not present at STRI. Such exclusive use of a space may incur a fee. Please contact the facility's scientific coordinator for more information
- Naos Molecular Laboratory: The Naos Molecular Laboratory (NML) provides molecular and sequencing facilities to all members of the STRI community. All users of the NML must pay a bench fee of \$25/week (\$100/month) when working in the lab. This fee provides users with access to all equipment, use of a lab bench, some plastics, other disposable supplies, and access to computers for data analysis. Other reagents can be purchased from laboratory stocks at cost. We also provide training in laboratory and data analysis protocols. Contact Eyda Gomez (gomeze@si.edu) for more information.
- Analytical Biogeochemistry Laboratory: The STRI Analytical Biogeochemistry Laboratory (ABL) is an interdisciplinary laboratory that supports STRI scientists as well as visiting researchers and external institutions. The ABL can provide laboratory space with basic equipment and operates several major analytical instruments that can perform analyses on a wide variety of environmental samples including soils, waters, plant and animal tissue.
